## SCOTTS VALLEY FIRE PROTECTION DISTRICT Regular Board Meeting February 10, 2021

5.1 <u>LAFCO Letter to Solicit Nominations for the regular and alternate member seats on the Consolidated</u>
Redevelopment Oversight Board in Santa Cruz County

Chief Whittle stated that LAFCO is soliciting nominations for the regular and alternate member seats for the Consolidated Redevelopment Oversight Board. There is no Board action required but if anyone is interested, the application is included in the board packet. President Parker added that the application deadline is February 26<sup>th</sup>.

#### 6. Action Items

Approve Resolution 2021-1: Resolution Acknowledging Receipt of a Report made by the Fire Chief of the Scotts Valley Fire Protection District (SVFPD) Regarding the State Mandated Annual Inspections of certain Occupancies Pursuant to Sections 13146.2 and 13146.3 of the California Health and Safety Code, Discussion/Action

Chief Whittle stated that based on the Grand Jury report from last year, the recommendation was for fire departments to report the state mandated inspection findings to the public. Administrative Captain Vandervoort will review the mandated inspections.

Administrative Captain Vandervoort stated that based on Senate Bill 1205, Fire Districts are required to report the status of state mandated inspections for certain occupancies to their Board of Directors. For the 2020 calendar year, all 25 state mandated inspections have been completed and we are 100% compliant. For all occupancies with violations, they are working to have them corrected and I am confident they will be resolved for the 2021 inspection. For the most part, the violations are for the 5-year sprinkler inspection, which has been delayed due to Covid.

President Parker inquired about the large number of violations at the Scotts Valley Middle School and Director Campbell inquired about the Scotts Valley High School sprinkler issues.

Administrative Captain Vandervoort stated that the majority of the violations at the Scotts Valley Middle School were missing evacuation maps posted at the door in each classroom. For Scotts Valley High School, the sprinkler system is functional but in need of maintenance repairs, which they are working on. Chief Whittle stated that we will continue to follow up until the violations have been resolved.

## 7.2 <u>Administrative Report - Chief Officers</u>

The Administrative Report was included in the board packet and Chief Whittle reported the following:

- On January 19<sup>th</sup>, the county experienced a large wind event and crews responded to over 40 calls for service including 2 wildland fires in the SVFPD. In addition, we responded with a type 3 engine and water tender to the Panther Fire and a type 3 engine to the China Grade Fire. Both incidents will be reimbursed by OES.
- Due to debris flow concerns in the burn areas, we participated in a County pre-assembled local government Task Force with a type 3 engine.
- Battalion Chief Theilen announced his retirement for March 6<sup>th</sup>.
- The Battalion Chief and Captain Test is scheduled for February 22<sup>nd</sup> and the application deadline is February 15<sup>th</sup>. With Battalion Chief Theilen's retirement, we will be promoting 2 Battalion Chiefs.
- An email was sent with a link for the mandatory board training. If you click on the email link and enter
  your SVFPD email, it will take you to the training page. You will also receive an email from our IT
  provider Pagoda Technology for a training link for cyber threats.

The BFPD Board was interested in talking with Central Fire to take over management but based on my discussion with the new Central Fire Chief, they will be focusing on completing their consolidation for the next several years. At this point, the best option is for the BFPD Board to promote a Fire Chief from within.

#### Dear Chief Whittle:

I am writing to request your assistance as LAFCO initiates a comprehensive study of fire protection in Santa Cruz County. Our study will primarily focus on cities and districts that provide fire protection services, but it will also discuss the services provided by a critical network of local, state, and federal agencies, as well as volunteer departments.

We will highlight each agency's accomplishments, goals and challenges, and may suggest opportunities for partnerships, efficiencies and effectiveness. We will also discuss current issues and trends affecting service delivery. Finally, the study will review and may recommend changes to the boundaries and spheres of influence of cities and special districts that provide fire protection services. Your participation will add value to the LAFCO study process and its outcome.

## Request for Information

Information gathering is the first step in our study. Please complete the enclosed survey and return it to our office by April 2, 2021. Let us know if you have any questions or need additional time. LAFCO staff may request a meeting with you or your designated representatives to discuss the survey data as the study progresses.

#### **Next Steps and Schedule**

After we receive information from surveys, interviews, and other resources, LAFCO staff will prepare an administrative draft study for review by all affected agencies. We will provide this draft to you early in June 2021 with a request for internal review and comments. Our intent is to ensure its accuracy in content and tone.

The final step is a public hearing process. Staff will complete a public hearing draft study and schedule a LAFCO public hearing to consider and adopt the study and its recommendations. We will share the public hearing draft study with you and inform you of ways to participate in the hearing process. The hearing and study adoption will be completed by October 2021. Any outcomes that require follow-up will be addressed in the new fiscal year.

## **Operations**

Captain Ronzano has been upgrading the lights at the Glenwood station to LED. Replaced all the apparatus bay fluorescent bulbs to LED as well as any old fluorescent can lights inside of the station. Any remaining fluorescent will be replaced out with LED lights as they burnout.

He should be on schedule to start the driving and pumping portion of his probation within the next few months. He has obtained his Class B permit and is ready to keep moving forward.
